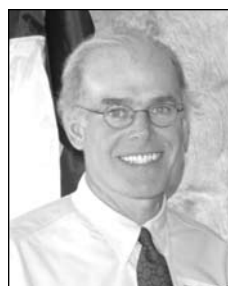

Members of the West I-10 Chamber of Commerce met for their regularly scheduled meeting at the Texas Traditions Restaurant in Fulshear. Chamber President, Greg Turner, called the meeting to order. After each person present introduced themselves, lunch was

served to the crowd.

While lunch was served, members were able to speak among themselves and get to know one another better. After lunch, Turner presented West Engineering and Igloo products with certificates for their sustaining memberships.
